#01-18-2079, the first Title IX complaint to challenge discrimination against men at an Ivy League institution (Yale University),

#06-18-2230, a Title IX complaint that transformed the all-women Newcombe College into a coeducational facility (Tulane University).

#11-19-2003, a precedential complaint which established that employment preferences for women violate Title IX (Georgetown University).

Opposition to Nepotism & Affirmative Action (United States)

#01-20-2160, a precedential complaint which argued that Brandeis University violated Title VI by offering preferential treatment for Jewish and Polish-Jewish students. The complaint also alleged that American universities offer affirmative action preferences for Jews, Blacks, Latinos – while penalizing Whites and East Asians (which preference is now eliminated, as per *Students for Fair Admissions v. Harvard* (2023)). This ruling established that scholarships exclusively for Jewish students violate Title VI.

The resignation of Kenneth Marcus. After an extensive signature campaign, I was instrumental in compelling the resignation of Kenneth Marcus – a far-right Jewish activist who was engaging in invidious discrimination against Christians and Muslims. (He had been confirmed to this position at the United States Senate).

Sanctions & International Petitions (UK, US, ICC)

Petition for Global Magnitsky Sanctions with the United States

Congress. I have petitioned the bipartisan Tom Lantos Human Rights Commission to press war crime & corruption charges against Turkey, with some degree of success (2019).

Petition for Sanctions with the United Kingdom Foreign &

Commonwealth Office. I have petitioned the United Kingdom Foreign & Commonwealth Office to press war crime & corruption charges against Turkey. I have received a warm personal response from the Office on 20 August 2020, detailing how the United Kingdom was combating human rights abuses in Turkey.

Human Endangerment, Ideological Censorship, Ethnic Nepotism

Complaint (versus China & Israel). Upon review of scientific literature and public evidence, I concurred (in 2020 and onwards) that COVID-19 is a synthetic virus originating from the Wuhan Institute of Virology. I concurred that there exists overwhelming evidence of microbiological manipulation. I concurred that further analysis is necessary to examine nanotechnological manipulation. I argued that the circumstances leading to the release of COVID-19 constitute violations of international law, as enshrined in the Rome Statute and various conventions of the United Nations. I argued that there exists some degree of criminal collusion between China and Israel in the synthesis and release of COVID-19. I also raised various concerns about ideological surveillance and ethnic nepotism in the United States. ICC noted the submission, added it to its archive, and gave me leave to file an amended complaint (pending).
